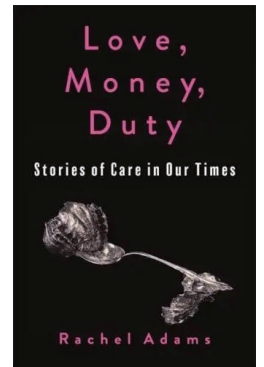

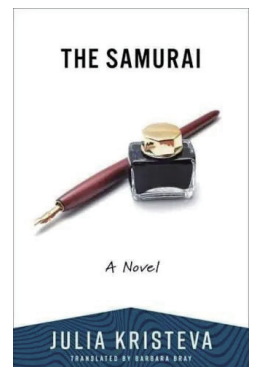

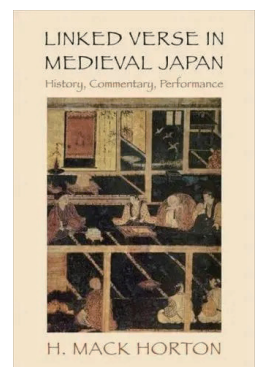

Linked verse (*renga*) was the most popular form of poetry in Japan's medieval era (c. 1200-1600 CE). Renga poets linked verses of seventeen and fourteen syllables into long sequences in accordance with complex rules and literary allusions; the first verse, which initially stood alone, was the ancestor of the modern haiku. Courtiers, warriors, and commoners alike practiced linked verse in an atmosphere of literary artistry, scholarship, social sensitivity, and charged competition. The masters were often invited at great expense to warrior domains to preside at linked-verse sessions and provide instruction in the art. Some of Japan's most famous poets, notably Sōgi and Bashō, composed not only revered renga works but also books of guidance, history, theory, and commentary. This book is the most comprehensive work in English on premodern Japanese linked verse.

*Critically Capitalist* presents an ethnography of South Korea's asset seekers, including amateur stock investors, real estate enthusiasts, and money coaches, to demonstrate how financialized asset capitalism is sustained. As they hunt for profit margins, rent, and dividends, they simultaneously critique capitalism and posit their pursuit of assets as a form of resistance. Bohyeong Kim theorizes this new spirit of capitalism in South Korea as "critical capitalism," arguing that it reflects the popular discontent with both national development and financial neoliberalism. As a paradoxical critique and legitimation, Bohyeong Kim argues that critical capitalism valorizes the capitalist economy not through a triumphant narrative, but by highlighting the emotional wounds, destroyed communities, and oppressive tactics of modern capitalism.

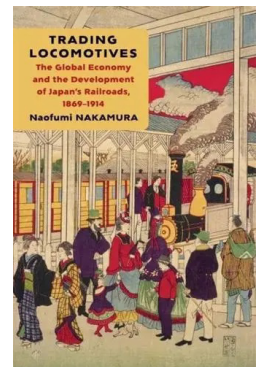

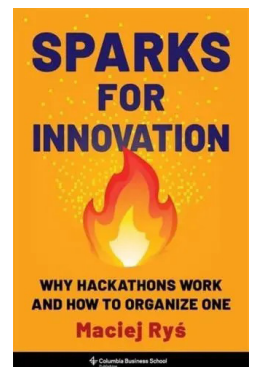

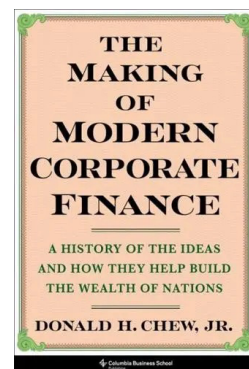

*The Terrorism News Beat* engages thinking about terrorism and the news media from the fields of political science, communication, criminology, economics, and sociology using multimethod research involving more than 2,500 newspaper articles published between 1997 and 2018. Chapters analyze the terrorism news beat’s subject matter, language, and coverage of the Oklahoma City Bombing, Olympic Park bombing, 9/11 attacks, DC Sniper case, and Dallas Police shooting. When it comes to language use, Hoffman finds that, rather than giving into the temptation to convey the news in lurid detail, journalists are minimalists. The language used to depict events on the terrorism beat is typically moderate and extreme words like “torture” appear only as necessary.

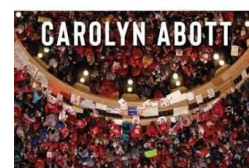

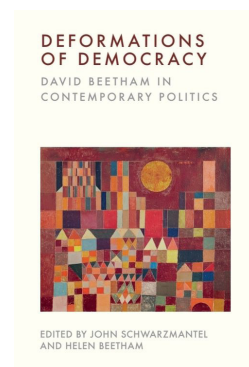

Between 2012 and 2022, political parties challenged the results of more than 25 percent of elections. When democratic transitions are dependent on the willingness of participants to accept defeat, political parties can undermine election-based democracy by rejecting the outcome. As the world enters the fourth decade since the start of the third wave of democratization, the question of whether election losers will comply or reject election outcomes is more and more pressing. *The Dilemma of Compliance* analyzes this phenomenon at the level of political parties, raising three important questions: Why do some political parties refuse to comply with election results? What determines the strategies they use to contest the outcomes? What consequences do post-election disputes have for the political parties that initiate them? To answer these questions, this book draws on an original dataset of post-election responses encompassing over 300 political parties, which participated in 270 elections held in twenty-two countries of Eastern Europe and the former Soviet Union over a period of more than two decades. In doing so, it offers a new theoretical framework for studying electoral compliance in comparative perspective and advances research on democratic transition, democracy promotion, post-election protests, and party politics.

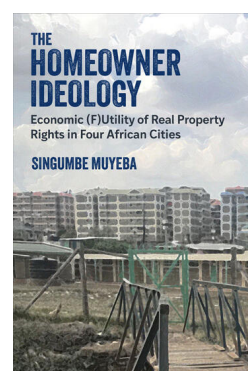

While homeownership has clear benefits among the impoverished, *The Homeowner Ideology* shows that the utility of real property rights as an economic resource are severely limited in sub-Saharan African cities. Although global poverty has declined since 1990, it remains widespread in Subsahara, the region with the highest proportion of the global population living in slums. Mainstream thinking in development studies is dominated by market fundamentalist neoclassical economics and the premise that ownership reduces poverty. Singumbe Muyeba contends that this neoliberal premise is flawed and unsupported by data within the African context.

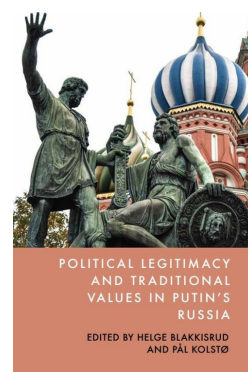

Since Vladimir Putin's return to the Russian presidency in 2012, protection and promotion of so-called 'traditional values' has played a prominent role in the Kremlin's propaganda campaigns. From the large-scale demonstrations in 2011-2012 to the full-scale invasion of Ukraine in 2022, conservative social values have been mobilised to justify the Kremlin's policy choices. In the case of the invasion, for example, Putin argued that the allegedly 'decadent' western world was using Ukraine as a springboard to export its 'pseudo-values' into Russia. Drawing on a series of case studies spanning elite-level political rhetoric, the work of various ideological 'values entrepreneurs' such as the Russian Orthodox Church, and, not least, of grassroots sentiments, *Political Legitimacy and Traditional Values in Putin's Russia* explores authoritarian regime legitimization in today's Russia.

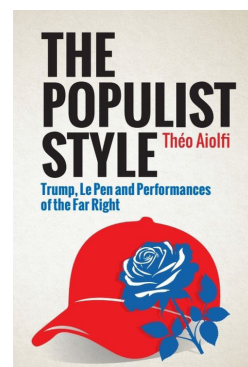

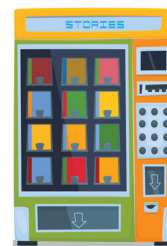

*Story Tech* explores the increasingly influential impact of technologies - such as databases, algorithms, and digital story banks - that are usually invisible to the public. It shows that hidden "story tech" enables political organizations to treat stories as data that can be queried for storylines and used to intervene in news and information cycles in real time. In particular, the authors review successful story-centered campaigns that helped change dominant narratives on disability rights, marriage equality, and essential workers' rights in the United States and Australia. They compare the use of storytelling advocacy across different types of organizations including volunteer grassroots groups, large national advocacy coalitions, and trade unions, and examine how trends differ for storytellers, organizers, and their technology partners.

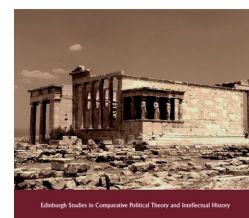

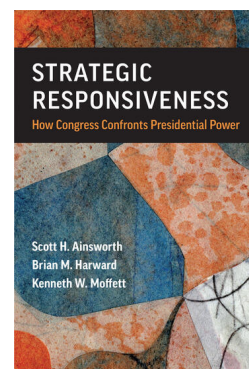

*Strategic Responsiveness* takes a theoretically developed and empirically oriented approach - situated within legal and historical contexts - to explore the system of separated powers. The authors find that Congress is not as weak as many perceive it to be and show how members of Congress often anticipate individualized policy loss and choose to respond. These policy struggles shape the constitutional order as surely as broad, statutory constraints might. While the aggrandizement of the presidency and the usurpation of congressional control are not countered, ordinary policy losses are. For members and senators, presidential overreach is fine as long as the policy wins continue, but policy losses may motivate members to reassert congressional prerogatives in policymaking through increased oversight. *Strategic Responsiveness* reveals how profoundly important policy-level disputes are in the politics of maintaining a particular constitutional order.

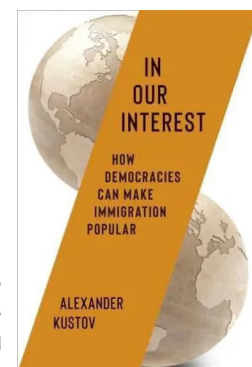

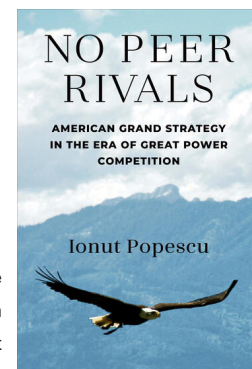

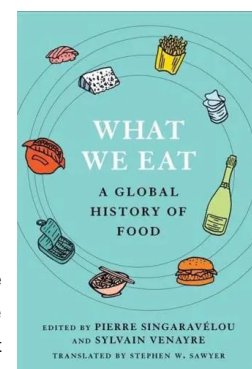

The baguette is mythologized as a product of the French Revolution, but in fact it emerged during late-nineteenth-century urbanization. Colonialism brought baguettes to Vietnam, where street vendors devised a new dish: banh mi, which refugees took with them around the world. 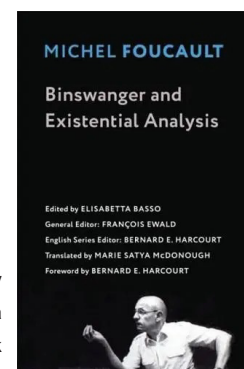

He gave a lecture course on this topic at the University of Lille in the spring of 1953 and wrote a detailed introduction to the 1954 French translation of Binswanger's *Dream and Existence* (1930), in which he promised a forthcoming book that would "situate existential analysis within the development of contemporary reflection on man." This book presents Foucault's unpublished manuscript on Binswanger and existential analysis for the first time in English, offering crucial insight into his intellectual development.

Badiou traces the permutations of this connection among fundamental concepts as it was transmitted to later thinkers, including Plato, Aristotle, Descartes, Hegel, and Heidegger. He also argues that Parmenides's account of philosophy establishes a new kind of formal reasoning that, like mathematics, breaks with the Greek mythic and poetic traditions and their assumption that truth derives from sensory experience. An important prehistory for Being and Event, this seminar demonstrates Badiou's unparalleled ability to recast the fundamental questions of philosophy.

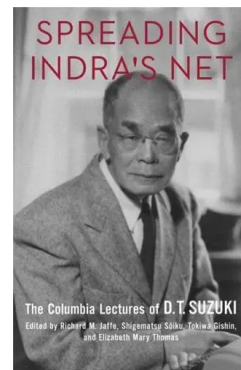

D. T. Suzuki's 1950s lectures at Columbia University were foundational for the postwar Zen boom. He offered a distinctive interpretation of Zen, weaving together his understanding of classical Buddhist texts, especially the *Flower Garland Sutra*, with Christian mysticism, psychology, and twentieth-century European and American philosophy. The freewheeling lectures captivated an audience drawn from the New York intelligentsia and art world - including Carolyn Brown, John Cage, Arthur Danto, Sari Dienes, Erich Fromm, Phillip Guston, Ibram Lassaw, and Dorothy Norman - and catalyzed public interest in Buddhism.

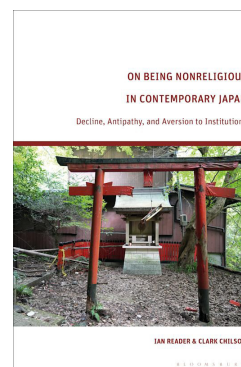

This book challenges this answer by arguing that many Japanese say they are nonreligious because they actually dislike religion and want to distance themselves from it. Against the background of the prolonged US military presence in post - World War II Okinawa, *The Community of Nuchi Du Takara* ("Life Is the Ultimate Treasure") in *Postwar Okinawa* explores the conflict between Okinawa and the US-Japan alliance. Developing the local notion of *nuchi du takara* into an analytical concept, Inoue examines how Okinawan activists, artists, writers, and other social actors have resisted US military presence, particularly the planned construction of a new military facility in northern Okinawa. The concept of *nuchi du takara* also helps Inoue explore complex negotiations Okinawa has had with Washington and Tokyo beyond resistance and protest, a process that involves developing a local communal capacity to embrace diverse and often contradictory attitudes toward the US military.
