Italian cinema is now regarded as one of the great cinemas of the world. Historically, however, its fortunes have varied. Following a brief moment of glory in the early silent era, Italian cinema appeared to descend almost into irrelevance in the early 1920s. A strong revival of the industry which gathered pace during the 1930s was abruptly truncated by the advent of World War II. The end of the war, however, initiated a renewal as films such as *Roma città aperta* (Rome Open City), *Sciuscià* (Shoeshine, 1946), and *Ladri di biciclette* (Bicycle Thieves, 1948), flagbearers of what soon came to be known as Neorealism, attracted unprecedented international acclaim and a reputation that only continued to grow in the following years as Italian films were feted worldwide. Ironically, they were celebrated nowhere more than in the United States, where Italian films consistently garnered the lion's share of the Oscars, with Lina Wertmüller becoming the first woman to ever be nominated for the Best Director award.

Inside are scholarly essays by experts, with more than 100 rich color illustrations from the collections of the Hoover Institution Library & Archives, including woodblock prints, photos, posters, and the rarely examined street paper plays called kamishibai, many of which had been destroyed or lost by the end of the Second World War. Spanning from the First Sino-Japanese War through World War II, these important documents build a visual narrative that charts the rise of an imperialist nation and demonstrates how expansionist policy disseminated through mass media to shape a modern Japan, forever changing political relations between East and West and between Japan and its neighbors.

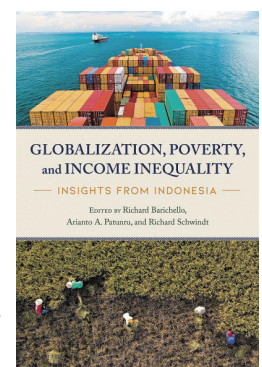

Globalization, Poverty, and Income Inequality examines the relationship between globalization and trade liberalization, and poverty and income inequality, using Indonesia as a case study. Using both aggregate data and local evidence, this empirically rigorous investigation finds that although increased trade tends to reduce poverty, there are exceptions. Globalization via trade in certified organic coffee has not helped low-income farmers. Globalized access to treatments for visual problems has been countermanded by rising digitization that negatively affects visually disabled people, especially those who are also poor. And although globalized standards of well-defined property rights are normally a precondition for urbanization, economic growth, and poverty alleviation, they can clash with the traditional or informal property rights of an urban underclass.

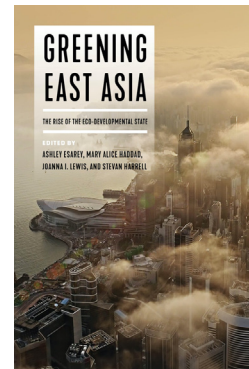

It also produces a third of worldwide greenhouse gas emissions, making it a major contributor to climate change. The region - whose countries share ecological, sociocultural, and political characteristics while varying in size, resource wealth, history, and political systems - offers excellent insights into the complex dynamics influencing environmental politics, advocacy, and policy. With essays addressing Japan after Fukushima, coal plants and wind turbines in China, environmental activism in Taiwan, and sustainable rural development in South Korea, *Greening East Asia* explores a region's shift from development to "eco-development" in acknowledgment that environmental sustainability is a critical component of economic growth.

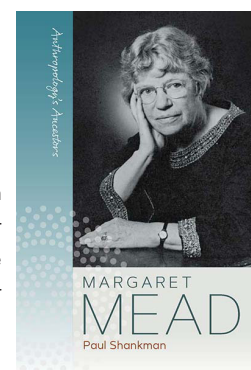

The criticisms of Mead are also discussed and analyzed. This short volume is an ideal starting point for anyone wanting to learn about, arguably, the most famous anthropologist of the twentieth century.



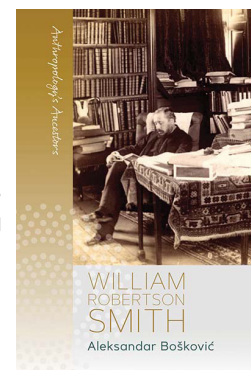

William Robertson Smith's influence on anthropology ranged from his relationship with John Ferguson McLennan, to advising James George Frazer to write about "Totem" and "Taboo" for the *Encyclopaedia Britannica* that he edited. This biography places a special emphasis on the notes and observations from his travels to Arabia, as well as on his influence on the representatives of the "Myth and Ritual School." With his discussion of myth and ritual, Smith influenced generations of scholars, and his insistence on the connection between the people, their God, and the land they inhabited inspired many of the concepts later developed by Émile Durkheim.

Continuing rural-urban migration, declining birth rates, and an aging population only compound the worrying phenomenon of shrinking cities.

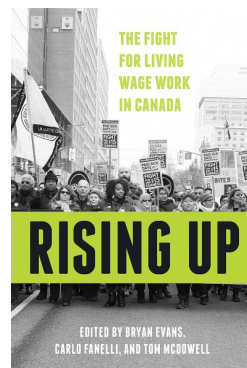

Rising Up traces the history and international context of living wage movements across Canada. Contributors to this astute and compassionate collection of essays examine union- and community-based approaches to organizing in marginalized communities, the role of social reproduction, migrant labour, and media (mis)representations, among other key topics. In the 1970s, the balance of political and economic power began to shift in favour of business, as trade unions weakened and governments proved unwilling to check corporate power. By the 2000s, austerity measures had dismantled social services spending, facilitating the growth of precarious, often gendered or racialized low-waged employment. Rapidly increasing wealth and income inequality has followed in the wake of these deteriorating labour market conditions and mounting social disparities.

Exploring the different manifestations of global apartheid, Besteman traces how militarization and securitization reconfigure older forms of white supremacy and deploy them in new contexts to maintain this racialized global order. Whether using the language of security, military intervention, surveillance technologies, or detention centers and other forms of incarceration, these projects reinforce and consolidate the global north's political and economic interests at the expense of the poor, migrants, refugees, Indigenous populations, and people of color.

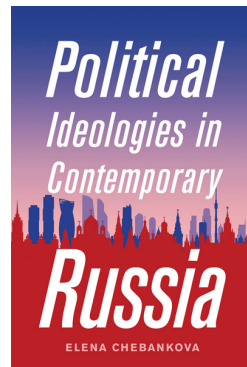

Contrary to the view that a bleak discursive uniformity reigns in Vladimir Putin's Russia, shows that the country is engaging in serious theoretical debates across a wide spectrum of modern ideologies including liberalism, nationalism, feminism, and multiculturalism. Elena Chebankova argues that the nation is fragmented and the state seeks to balance the various ideological movements to ensure that none dominates. She shows that each of the main ideological trends is far from uniform, but the major opposition is between liberalism and traditionalism. The pluralistic picture she describes contests many current portrayals of Russia as an authoritarian or even totalitarian state.

After World War II Berlin became one of the playgrounds of the Cold War; the Berlin Wall made the division between East and West, between 'capitalism' and 'communism' in 1961 highly visible, though it did remove Berlin from front-line politics. East and West Berlin had turned into shop-windows of ideologies - West Berlin representing the lure of a market economy, East Berlin the promise of socialism. It is, then, fitting that the fall of the Wall in 1989 awarded Berlin such a prominent role. It was here that the development after Reunification of East and West became a closely observed event - and, well beyond Germany, Berlin appeared to represent fundamental developments throughout Europe at the time. Today, Berlin is the capital of reunified Germany and therefore one of the key political players in the European Union (EU) and it's now a desirable destination for young entrepreneurs. *The Historical Dictionary of Berlin* contains a chronology, an introduction, and an extensive bibliography.

The Syrian situation turned into a winter, which merits such an all-encompassing book that reveals the complex dynamics of the Syrian civil war. Many of the key players, places, and unfolding events were making headlines for a short period before vanishing from memory, but this book records their emergence and influence. The book traces the political opposition, initially in the form of street-level unrest, targeting the rule of the al-Asad family that ruled for over five decades.

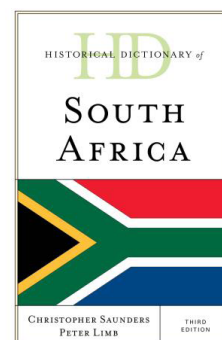

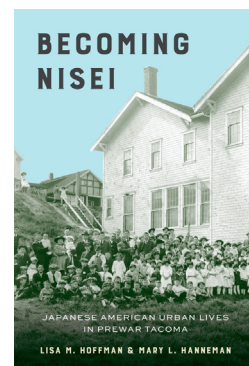

Demanding liberation, advocating for the oppressed, and organizing for justice, siblings Mitsuye Yamada (1923-) and Michael Yasutake (1920-2001) rebelled against respectability and assimilation, charting their own paths for what it means to be Nisei. Raised in Seattle and then forcibly removed and detained in the Minidoka concentration camp, their early lives mirrored those of many second-generation Japanese Americans. Yasutake's pacifism endured even with immense pressure to enlist during his confinement and in the years following World War II. His faith-based activism guided him in condemning imperialism and inequality, and he worked tirelessly to free political prisoners and defend human rights. Yamada became an internationally acclaimed feminist poet, professor, and activist who continues to speak out against racism and patriarchy.
