It is often assumed that deindustrialization is a bad thing, confined to the Global North, and caused by cheap imports from the Global South. Although not entirely incorrect, the truth is far more complicated. Ray Kiely argues that the current economic debate assumes too much in terms of causality around deindustrialization, which is better seen as a product of wider changes in contemporary global capitalism. Yet, evidence of a zero-sum game doesn't have to be very strong for this to have become an issue of deep politics, informing right-wing populism and contemporary geopolitical tensions (namely with China). A clearer understanding of the processes of deindustrialization can help in appreciating the political responses and movements across the Global North - and South - and enable us to find better responses to the processes themselves.

In *The Banality of Good*, Lieba Faier examines why contemporary efforts to curb human trafficking have fallen so spectacularly short of their stated goals despite well-funded campaigns by the United Nations and its member-state governments. Focusing on Japan's efforts to enact the UN's counter-trafficking protocol and assist Filipina migrants working in Japan's sex industry, Faier draws from interviews with NGO caseworkers and government officials to demonstrate how these efforts disregard the needs and perspectives of those they are designed to help. She finds that these campaigns tend to privilege bureaucracies and institutional compliance, resulting in the compromised quality of life, repatriation, and even criminalization of human trafficking survivors. Faier expands on Hannah Arendt's idea of the "banality of evil" by coining the titular "banality of good" to describe the reality of the UN's fight against human trafficking.

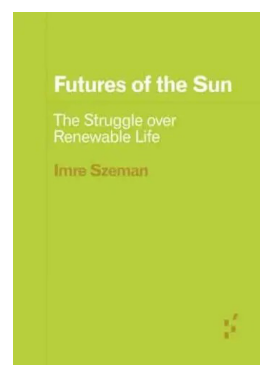

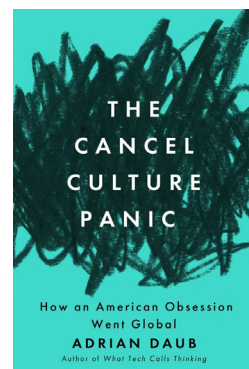

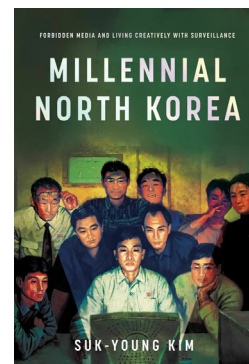

This expansion took place amid extreme economic hardship and the ensuing possibilities of destabilization. To capture these entanglements, Amélie Barras analyzes - through interviews, ethnography, and document and archive analysis - the everyday human rights work of Christian NGOs at the United Nations Human Rights Council.

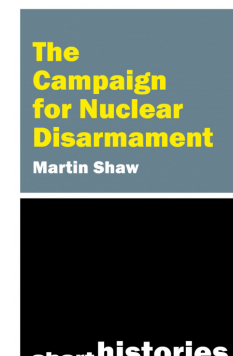

It examines how the campaign influenced - and was influenced by - antiwar movements from Vietnam to Iraq and Gaza, as well as the environmental and women's movements.

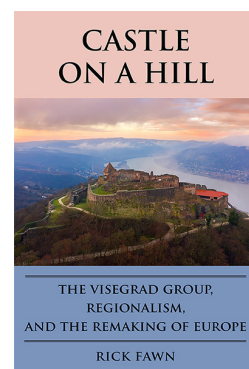

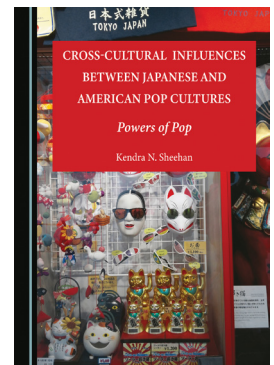

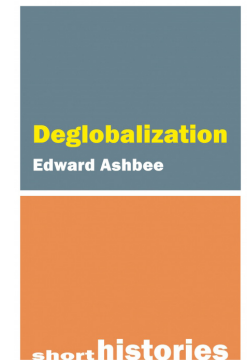

The book looks at the original promise held out by globalizing trends which became fully evident at the same time as the dot.com economy became part of everyday life. The book then charts the backlash against "globalism" and the ways in which it became pronounced across much of Europe, North America and Asia. And it asks how far has that backlash, together with the 2008 financial crisis, the Covid-19 pandemic, and the rise of "techno-nationalism" led to a stalling or even reversal in globalizing processes. The analysis disaggregates the different trends that collectively constitute "globalization" and surveys competing perspectives on globalization and reviews the arguments of those who argue that the concept is either myth or hyperbole. The book reveals how globalization is being reconfigured in ways that weaken its former associations with neoliberalism and Americanization thereby laying the basis for a new economic and social settlement.

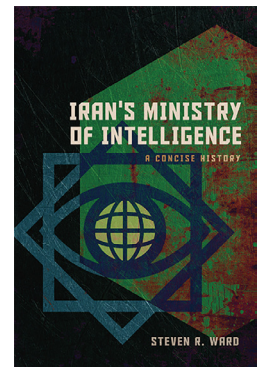

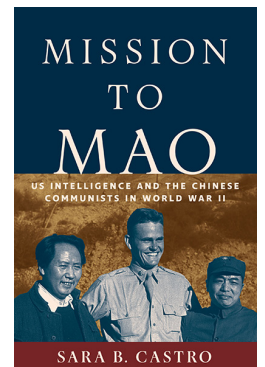

From 1944 to 1947, the United States planted a liaison mission in the headquarters of Chinese Communist forces behind the lines. Nicknamed the "Dixie Mission," for its location in "rebel" territory, it was an interagency delegation that included intelligence officers from the Office of Strategic Services (OSS), the US Army, and the State Department. *Mission to Mao* is a social history of the OSS officers in the field that reveals the weakness of US intelligence diplomacy in the 1940s. Drawing on over 14,000 unpublished records from five archives as well as white papers and memoirs from the participants, Sara B. Castro demonstrates how the US intelligence officers in China clashed with political appointees and Washington over the direction of the US relationship with the Chinese Communists.

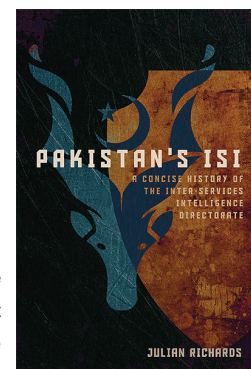

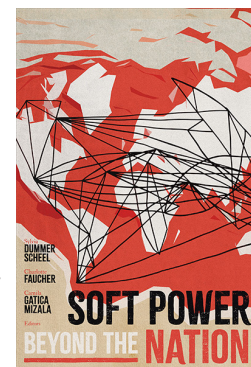

Soft Power Beyond the Nation takes a distinct approach to the study of soft power in history, moving beyond the framework of the nation-state. The volume editors use "soft power" to refer to the processes through which persuasion, the search for influence and power, and public opinion converge in the international arena. The book is organized on the basis of three central themes: the transnational circulation of knowledge and strategies of public diplomacy across borders, collaboration of intermediary actors of soft power whose interests did not always coincide with those of the state, and the role played by nonnational identities, such as gender and race, in soft power.

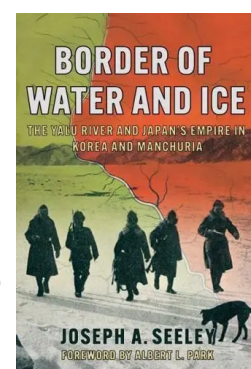

Border of Water and Ice explores the significance of the Yalu River as a strategic border between Korea and Manchuria (Northeast China) during a period of Japanese imperial expansion into the region. The Yalu's seasonal patterns of freezing, thawing, and flooding shaped colonial efforts to control who and what could cross the border. Joseph A. Seeley shows how the unpredictable movements of water, ice, timber-cutters, anti-Japanese guerrillas, smugglers, and other borderland actors also spilled outside the bounds set by Japanese colonizers, even as imperial border-making reinforced Japan's wider political and economic power.

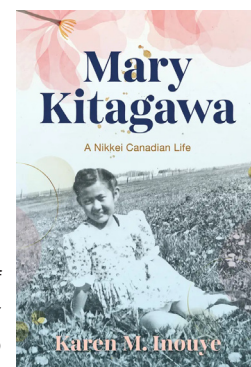

This book tells the story of Japanese Canadian activist Mary Kitagawa. In the aftermath of the Pearl Harbor bombing, Mary was one of roughly 22,000 Nikkei uprooted from their homes on the Pacific coast and forbidden to return to western British Columbia until long after World War II had officially ended. In the decades that followed, Mary and her family navigated financial precarity and ostracism, but also found ways to pursue both economic stability and political engagement. Beginning with Mary's grandparents, who were among the earliest immigrants to Canada from Japan, this book tracks the family's experiences - and those of the larger Nikkei Canadian community - from the late 1800s to the present.

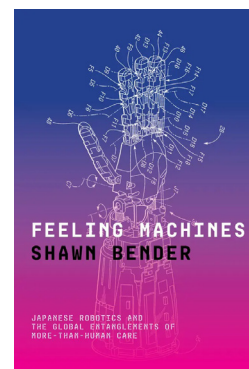
