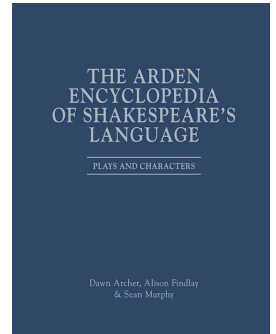

Arden Encyclopedia of Shakespeare's Language (Arden Shakespeare)

This third volume focuses on keywords in Shakespeare's plays. Play keywords are derived by conducting a statistical comparison between the words in one play with those in all the other plays. For characters, the statistical comparison is made between the vocabulary of one character and that of all the other characters in the same play. These keywords are then used to create 'linguistic profiles' of each play and main character. The profiles show how patterns of words around keywords contribute to themes in plays and characterization of the protagonists. For example, we reveal how the simple word 'Goodnight' contributes to dramatic tension in *Julius Caesar*, or how in *Romeo and Juliet*, Juliet's most distinctive yet apparently innocuous words, 'if', 'yet' and 'but', create an important aspect of her character.

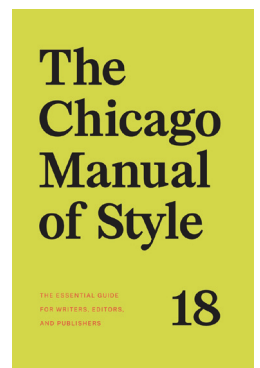

Much has happened in the years since the publication of the seventeenth edition of *The Chicago Manual of Style*. The world has transformed, and the *Manual* has risen to meet the moment. The eighteenth edition of this classic guide for writers, editors, and publishers is the most extensive revision in two decades.

Every chapter has been reexamined with diversity and accessibility in mind, and major changes include updated and expanded coverage of pronoun use and inclusive language, revised guidelines on capitalization, a broader range of examples, new coverage of Indigenous languages, and expanded advice on making publications accessible to people with disabilities. *The Manual's* traditional focus on nonfiction has been expanded to include fiction and other creative genres in coverage of topics such as punctuation and dialogue, and the needs of self-published authors receive wider attention.

The citation chapters have been thoroughly reorganized for the benefit of new and experienced users alike, and the key concepts for editing mathematics have been integrated into the chapters where they will be most useful to generalists. Evolving technologies - from open-access publishing models to AI - are covered throughout. And naturally, there are some well-considered updates to familiar rules, including changes intended to align the *Manual's* recommendations more closely with real-world usage. As with every new edition, devotees of the *Manual* will find much to discover and ponder.

Paul Kane has been called the founding father of Canadian art, and *Wanderings of an Artist among the Indians of North America* a classic of Canadian literature. Yet his studio canvases are stereotypically generic, and his book is infamous: in word and in image, it depicts vain, vengeful, vicious, violent, and vanishing Indigenous people, disregarding its subjects' lived experiences and providing little of ethnohistorical significance. *Paul Kane's Travels in Indigenous North America* rediscovers the primary fieldwork underlying Kane's studio art and book and the process by which his sketches and field writings evolved into damaging stereotypes with significant authority in the nineteenth century, in both popular and learned circles.
